U.S. International Trade Commission Negative Injury Findings

GDLSK represents foreign manufacturers, exporters, importers, and U.S. customers at the USITC to defend claims by U.S. producers that a domestic industry is being materially injured or threatened with material injury by dumped or subsidized imports. These cases require that an experienced team of GDLSK attorneys work closely with industry experts, economists, and counsel for other respondents. Our representation includes drafting responses to comprehensive questionnaires, compiling and submitting factual information, preparing briefs, participating at formal hearings, and coordinating with other parties. Our record of success at the USITC is second to none. Our victories span many industries in many countries, including:

U.S. Department of Commerce ADD/CVD Findings

GDLSK represents foreign manufacturers and exporters before the DOC in defending against claims by U.S. producers that imported merchandise is sold at less than fair value (ADD cases) and/or subsidized (CVD cases). DOC cases are extraordinarily complex. Failure to successfully participate could result in the DOC relying on adverse facts available (AFA) to calculate prohibitive ADD/CVD duty rates. In contrast, successful participation could result in *de minimis* ADD/CVD rates and exclusion of a foreign manufacturer from an ADD/CVD Order. U.S. Department of Commerce Circumvention

Rather than file new petitions targeting products from additional countries, domestic interests have at times filed AC petitions with the DOC claiming that third country processing is not sufficient to remove a product from an existing ADD/CVD order. DOC also has self-initiated AC proceedings. GDLSK responds to AC allegations with the same expertise and dedication provided in our traditional ADD/CVD practice. Appellate Reversals of Adverse ADD/CVD Decisions

The Court of International Trade (CIT) and Court of Appeals for the Federal Circuit (CAFC) are courts of exclusive jurisdiction which are tasked with hearing and resolving all issues arising under the customs and trade laws. GDLSK trade attorneys have extensive litigation experience.

We are responsible for landmark judicial decisions which have industry-wide impact, as well as cases which have resulted in victories solely for our clients based on the unique record we had developed before the agency. We support the DOC/USITC when we win before these agencies.

When we lose, we challenge the agency decision in the CIT/CAFC. Below are recent GDLSK wins reversing adverse DOC decisions.

- Wind Towers from Vietnam: CIT reversed Commerce on two complex substantive issues, and CAFC reversed CIT/Commerce on two other issues, reducing investigation rate from 50% to de minimis, resulting in respondent being excluded from ADD order.
- Pipe from India: CIT reduced Annual Review ADD rate from 11.83% to zero (seminal).
- Non-Malleable Cast Iron Pipe Fittings from China: CIT reversed Commerce decisions that products are within scope of ADD/CVD orders.
- Solar Panels from China: CIT reversed Commerce decisions that China's refusal to respond to EBCP questions justified reliance on AFA for this program (seminal).
- Nails from Taiwan: CIT reversed DOC AFA determination, reducing rate from 78.76% to zero.
- Nails from China: CAFC reversed CIT decision that plaintiff had not exhausted administrative remedies, leading to reversal of DOC decision on effective date of scope decision.
- Aluminum Extrusions from China: CIT/CAFC reversed DOC on effective date of anticircumvention decision (seminal).
- Nonwoven Ribbons from China: CAFC reversed DOC/CIT on ADD rate applicable to co-operative separate rate company (seminal).
- PVLT from China: CAFC reversed DOC/CIT on selecting merely one respondent in an Annual Review (seminal).
- Nails from Taiwan: CAFC reversed Commerce/CIT twice as to Commerce's calculation of the denominator in its differential pricing analysis (ongoing; on fourth remand).
